The Bid document shall be available for sale up to office hours till 29 January 2019.
- 4. Pre-bid meeting shall be held at TCN, Babarmahal, Kathmandu, Nepal at 11:00 A.M. on 17 January 2019.
- 5. Interested Bidders shall submit the Sealed Bid to the office of TCN, Babarmahal, Kathmandu, Nepal by hand/courier on or before 2:00 P.M on 30 January 2019. Bids received after this deadline will not be accepted.
- 6. Received Sealed Bids shall be opened in the presence of Bidders' representatives who choose to attend at **3.00 P.M.** on **30 January 2019** at the office of TCN, Babarmahal, Kathmandu, Nepal. But nothing shall bar the opening of Bid by the reason only that any bidder or its agent is not present. Bidder's representative should bear with authorization duly signed by the authority of firm at the time of Bid opening.
- 7. Bid must be valid for a period of **90 days**, counting from the day of bid opening and must be accompanied by bid security, amounting to minimum as specified in table below:
