5. Submitted Electronic Bids will be opened in the presence of Bidders' representatives who choose to attend at **1:15 P.M. on 20 September 2021** at the office of NBNL, **Babarmahal, Kathmandu, Nepal**.

Bids must be valid for a period of 90 Days counting from the date of Bid opening and must be accompanied by scanned copy of Bid Security in PDF format, amounting to a minimum of **NRs. 200,000.00** (In Words: Two Hundred Thousand Rupees Only), which shall be valid for minimum 30 days beyond the bid validity period (i.e., Valid up to minimum **17 January 2022**).
